TERMS & CONDITIONS

1. The undersigned User, agrees and certifies that the information detailed above is true and correct.

2. User represents and warrants that all facts stated in the Physical Activity Readiness Questionnaire (PARQ) submitted by The VSH User are true and correct. The PARQ is incorporated as part of the agreement.

3. Payment Terms

All payments to Vermosa Sports Hub are final, non-refundable, and non-transferable. VSH User is encouraged to pay the current VIP Pass fee plus applicable taxes. Please note that Vermosa Sports Hub reserves the right to change VIP Pass fees and product prices at their discretion.

4. Activation of VIP Pass will start upon completion of payments.

5. VIP Pass Access

The VSH User will be issued a Card which will entitle the VSH User to enter and enjoy the benefits of the Vermosa Sports Hub. The VSH User agrees not to allow others to access the facility with his/her VIP Pass Card. VSH Users may bring guests, but all guests are to check-in and pay regular facility rates. All Users are responsible for their guest.

Users with Monthly Unlimited Pool access may openly use the Pool except for days with scheduled events.

6. Facility Hours of Operation

The facility is accessible to Users upon checking in at the Reception daily from 5am to 10pm.

7. Release and Waiver of Liability

The VSH User recognizes that there are hazards and risks connected with physical fitness training.

These risks include, but are not limited to, abnormal blood pressure, fainting, heart disorders and heart attacks, dehydration, heat exhaustion, sprains, muscle strains, blisters, stress fractures, shin splints, tendonitis, cartilage tears, bursitis, back pain and bruising of the joints.

Training beyond one's physical limits and/or accidents involving exercise equipment may result in serious injury or death.

The VSH User agrees to defend, indemnify and hold Vermosa Sports Hub and its management, officers, agents and employees harmless from and against any and all loss, damage and expense incurred by reason of any claim or liability based upon personal injury (including death) or property damage arising out of the negligent or intentional action of the VSH User.

The VSH User further agrees to release Vermosa Sports Hub and its management, officers, employees and agents free and harmless from and against the same.

The VSH User agrees that they are voluntarily participating in these activities and use of the facility and premises and that all Users assumes all risks of injury, illness or death.

Additionally, The VSH User acknowledges that surveillance cameras are in use for the protection of the facility and its equipment. The VSH User gives consent to be photographed and/or recorded.

8. Rules and Regulations

The VSH User acknowledges that Vermosa Sports Hub operates under rules and regulations established for the safety and protection of patrons and agrees to be bound by them as well as by rules and regulations subsequently approved and posted or published by Vermosa Sports Hub.

Rules and regulations, in effect from time to time, are incorporated into this Agreement by reference.

Facilities, equipment, hours, service, regulation and policies are subject to change without prior notice, at the sole discretion of Vermosa Sports Hub and the VSH User agrees to accept such reasonable change as a condition of the VIP Pass.

The VSH User additionally recognizes:

- VSH Users are to conduct themselves in a quiet, well-mannered fashion so as not to cause any disturbance, which may interfere with the use of enjoyment of the facility by others.
- Profane or indecent language and/or behavior are not allowed.
- Any conduct deemed by Vermosa Sports Hub in its sole discretion to be offensive, potentially harmful, dangerous and/or abusive will not be tolerated.
- Any Users under the age of eighteen years are required to have a parent/guardian representative.
- Vermosa Sports Hub is not responsible for lost or stolen items on entire property, including inside facility, outside facility and vehicles of VSH Users.

9. Prohibited Items and Activities

NO alcohol, drugs or tobacco of any type allowed.

VSH Users may not use the facilities or engage in any activity at Vermosa Sports Hub while under the influence of drugs, alcohol or medication that may impair the ability to operate equipment.

Also, Vermosa Sports Hub does not permit tobacco of any kind, alcohol, illegal drugs in the facility or on the property.

No weapons of any kind are permitted in Vermosa Sports Hub or on its property.

No photography, videotaping, filming or audio recording is permitted without written permission of the management of Vermosa Sports Hub.

Vermosa Sports Hub reserves the right in its sole discretion, to limit the consumption of food or beverages in training area.

Vermosa Sports Hub reserves the right, in its sole discretion, to limit or restrict the use of outside equipment in the facility or on the premises.

Gambling or gaming is prohibited in the facility or on the premise.

10. Dress/Towel Policy

Vermosa Sports Hub requires you to wear appropriate clothing and footwear while in the training facility.

11. Lockers

VSH Users may use day lockers provided in the Locker Rooms, but must provide their own padlock.

VSH Users must remove all items from the locker when leaving.

Vermosa Sports Hub will not be responsible for the property removed from the lockers.

12. Entire Agreement

This agreement, and all documents mentioned hereto by reference, constitutes the entire agreement between VSH User and Vermosa Sports Hub.

It cannot be amended unless by mutual consent in writing by the parties.

This agreement may not be cancelled except as provided for herein.

13. Suspension and Termination

I understand that Vermosa Sports Hub may suspend or terminate my VIP Pass without any refund for failure to adhere to the terms of this agreement or for violation of the facility's policies and procedures.

14. Acceptance of Terms

As a VSH User, I understand that I am entitled to use the facilities, within the scope of the VIP Pass that I have selected and that I am obligated to pay my dues and fees regardless of whether I use the facilities.

As the primary VSH User or card holder I understand that I am responsible for any guests I invite, and will make sure that they are aware of the rules and regulations of Vermosa Sports Hub.

I agree to promptly update Vermosa Sports Hub of any changes of address, phone and credit information that may directly affect my VIP Pass agreement with Vermosa Sports Hub.

I certify that I have received, read and understood all the terms of the VIP Pass Agreement and agree with all of its terms, to be legally bound by the same to the fullest extent permitted by law.

I agree to release and discharge Vermosa Sports Hub and all affiliates, employees, agents and management from any and all claims or causes of actions and agree to voluntarily give up or waive any rights that I may otherwise have to bring a legal action against the club for negligence, personal injury and/or property damage.
